The Town of Egremont is pleased to announce that **NextEra Energy Services** ("NextEra") has been selected as the supplier for its Community Choice Power Supply Program ("Program"). NextEra will provide electric power supply for all consumers participating in Egremont's Program. This Program supports renewable energy and provides an additional 50% of Renewable Energy Certificates (RECs) over the amount required by the state, all originating from qualified Massachusetts Class I renewable energy sources. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will see NextEra printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.
