## THE TOWN OF HARVARD'S COMMUNITY CHOICE POWER SUPPLY PROGRAM CONSUMER NOTIFICATION

The Town of Harvard is announcing that **Direct Energy Services** ("Direct") has been selected as the supplier for its Community Choice Power Supply Program ("Program"). Direct will provide electric power supply for all consumers participating in Harvard's Program. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will see Direct printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**PARTICIPATING CONSUMERS** will start benefiting from the aggregation rate beginning on the day of the month in November 2022 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will be automatically enrolled. If you do not wish to participate, please follow the instructions specified.

**OPTIONAL BASIC PRODUCT** – You may OPT-IN to the meets MA renewable energy requirements product <u>at any time</u> by visiting <u>colonialpowergroup.com/harvard</u> or calling Direct at (866) 968-8065 and asking to be enrolled. This product is being offered at \$0.26630 per kWh for the first 6 months (November 2022 to April 2023), then changes and is being offered at \$0.12840 per kWh for the remaining 6 months (May 2023 to November 2023).

**IF YOU WISH TO JOIN THIS PROGRAM** you may OPT-IN at <u>colonialpowergroup.com/harvard</u> **OR** call Direct at (866) 968-8065 and ask to be enrolled. If you are currently contracted with your own competitive supplier, you should confirm with them that you will not incur any early termination fees or penalties for leaving their supply.
