

THE TOWN OF NORTH ANDOVER'S COMMUNITY CHOICE POWER SUPPLY PROGRAM CONSUMER NOTIFICATION

The Town of North Andover is announcing that **Direct Energy Services** ("Direct") has been selected as the supplier for its Community Choice Power Supply Program ("Program"). Direct will provide electric power supply for all consumers participating in North Andover's Program. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will see Direct printed under the "Supply Services" section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

NEW RATES AND TERMS

*Rate includes Consultant Fee of \$0.001 per kWh to facilitate North Andover's Community Choice Power Supply Program. *Rate may increase as a result of a change in law that results in a direct, material increase in costs during the term of the contract. **GreenUp options are available for \$0.012-\$0.038 per kWh in addition to National Grid's Basic Service rate.

PARTICIPATING CONSUMERS will start benefiting from the aggregation rate beginning on the day of the month in October 2022 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION you do not need to take any action to participate. You will be automatically enrolled. If you do not wish to participate, please follow the instructions specified.

OPTIONAL GREEN PRODUCT – You may OPT-IN to the 100% renewable product (includes 49% National Wind RECs) <u>at any</u> <u>time</u> by visiting <u>colonialpowergroup.com/north-andover</u> or calling Direct at (866) 968-8065 and asking to be enrolled. This product is being offered at \$0.25851 per kWh for the first 8 months (October 2022 to May 2023), then changes and is being offered at \$0.12716 per kWh for the remaining 4 months (June 2023 to October 2023).

IF YOU WISH TO JOIN THIS PROGRAM you may OPT-IN at <u>colonialpowergroup.com/north-andover</u> **OR** call Direct at (866) 968-8065 and ask to be enrolled. If you are currently contracted with your own competitive supplier, you should confirm with them that you will not incur any early termination fees or penalties for leaving their supply.
