THE TOWN OF LUNENBURG'S COMMUNITY CHOICE POWER SUPPLY PROGRAM RATE INCREASE NOTIFICATION

<u>IMPORTANT UPDATE:</u> The Town of Lunenburg's current aggregation rate will increase by \$0.0053 per kWh effective with the December 2022 meter reads to incorporate the enrollment of the Town's municipal buildings. The new rate (increasing from \$0.11210 per kWh to \$0.11740 per kWh) will be fixed through the remainder of the term, ending November 2024.

WHAT IS THE IMPACT OF THE RATE INCREASE? Given average usage of 600 kWh per month, the new aggregation rate represents an increase of \$3.18 per month versus the current rate. [For a per kWh comparison against Unitil's Basic Service rates effective December 1, 2022, please see the NEW RATES AND TERMS chart below.]

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will continue to see First Point printed under the "Supplier Services" section of your monthly bill. You will continue to receive one bill from Unitil. You will continue to send your payments to Unitil for processing. Unitil will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION you do not need to take any action to participate. You will be automatically enrolled. If you do not wish to participate, please follow the instructions specified.

BUDGET PLAN OR ELIGIBLE LOW-INCOME RATE CONSUMERS will continue to receive those benefits from Unitil.

SOLAR PANEL AND COMMUNITY SOLAR CONSUMERS will continue to receive net metering or on-bill credits while receiving electricity supply under the Program and the value of these credits will not be altered by participating in the Program.

^{**}Rates were revised November 15, 2022 and are subject to change when projected wholesale power supply costs for the balance of the period vary by more than 20% from the projected wholesale power supply costs at the time the rates were set.

ANY APPLICABLE TAXES WILL BE BILLED as part of the Program's power supply charge. You will be responsible for identifying and requesting an exemption from the collection of taxes by providing appropriate documentation.
