BURLINGTON ANNOUNCES NEW RATES AND SUPPLIER FOR ENERGY PROGRAM

BURLINGTON, MA – The Town of Burlington has signed a twenty-four month contract with a new supplier, First Point Power. Beginning with the October 2026 meter reads, the Burlington Community Choice Power Supply Program, designed to meet the specific needs of the Town's electricity ratepayers, will continue to offer the same options but at new rates:

- The standard product which meets the Massachusetts Renewable Energy Requirement (MA Req) of 69.1% at a rate of \$0.15646 per kWh.
- An optional product that meets the MA Req plus an additional 5% Massachusetts Class I Renewable Energy Certificates (RECs) at a rate of \$0.15846 per kWh.
- A second optional product which meets the MA Req plus an additional 25% Massachusetts Class I RECs at a rate of \$0.16646 per kWh.

For Burlington residents and businesses who are enrolled in the Town's standard product, the current rate of \$0.13229 per kWh will expire and the new rate of \$0.15646 per kWh will take effect with the October 2026 meter reads. This represents an increase of \$15 per month on the supply side of the bill given average usage of 600 kWh. However, this new rate is 10 percent lower than Eversource's Residential Basic Service rate of \$0.17323 per kWh. Residents can expect to see an average savings of \$10 per month for the months of October 2026 through January 2027.

Burlington re-launched its electricity program in October 2024 in an effort to develop an energy program that would be stable, affordable and incorporate renewable energy. From inception through March 2026, the Program has saved residents and small businesses over \$1.6 million in electricity costs as compared to Eversource Basic Service.

It is important to note that no action is required by current participants. All accounts currently enrolled in the Program will remain with their current product selection and see the new rate and First Point Power printed under the “Supplier Services” section of their monthly bill. This change will be seen on the November 2026 bills.

The Burlington Community Choice Power Supply Program has no fees or charges. However, anyone switching from a contract with a third-party supplier may be subject to penalties or early termination fees charged by that supplier. Ratepayers should verify terms before switching.

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the program against Eversource Basic Service. However, future savings cannot be guaranteed.

If you are a tax-exempt small business, you must email or fax a copy of your Energy Exemption Certificate directly to First Point Power at enroll@firstpointpower or (877) 206-4855 fax) in order to maintain your tax-exempt status.
