COMMUNITY CHOICE POWER SUPPLY PROGRAM



The Town of Kingston is announcing the new rates and term for its Community Choice Power Supply Program through its new electricity supplier, **First Point Power**. The Town's new aggregation rates are fixed **for all rate classes for 24 months** as follows:

For comparison purposes, Eversource's Residential Basic Service rate is fixed at \$0.16078 per kWh from July 1, 2023 through December 31, 2023. Eversource's rates will change on January 1, 2024 and should be known in late-November. Historically, Eversource's winter rates have been higher than their summer rates. The Town expects that will be the case again this winter, providing an opportunity for continued savings.

Given average usage of 600 kWh per month, the Town's new rate of \$0.14476 per kWh for its standard product represents a decrease of \$35 per month versus the current rate of \$0.20337 per kWh (expires on your December 2023 meter read; date varies by account).

It is important to note that <u>no action will be required</u> by individual consumers. All accounts currently enrolled in the Town's Program will be switched to First Point as of the December 2023 meter reads. This change will be noted on the December 2023 bills and will be seen on the January 2024 bills. Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the Program against Eversource Basic Service. However, such savings and future savings cannot be guaranteed.
