## NORTH ADAMS ENERGY PROGRAM ANNOUNCES NEW ELECTRICITY SUPPLIER AND RATE REDUCTIONS

NORTH ADAMS, MA – The City of North Adams has signed a thirty-six month contract with a new supplier, First Point Power. Beginning with the November 2025 meter reads, the North Adams Community Choice Power Supply Program will have a new rate of \$0.13750 per kWh. The Program will also continue to offer an optional product that uses 50% Massachusetts Class I RECs, at a rate of \$0.15750 per kWh.

For North Adams residents and businesses who are enrolled in the City's Program, the current rate of \$0.15051 per kWh will expire with the November 2025 meter reads and the new rate of \$0.13750 per kWh will take effect. This represents a decrease of \$8 per month on the supply side of the bill given average usage of 600 kWh. Additionally, this new rate is 11 percent lower than National Grid's current Residential Basic Service rate of \$0.15484 per kWh. Residents can expect to see an average savings of \$10 per month for the months of November 2025 through January 2026. National Grid's Basic Service rates will change on February 1, 2026.

North Adams launched its electricity program in November 2014 in an effort to develop an energy program that would be stable and affordable. From inception through March 2025, the Program has saved residents and small businesses over \$5.7 million in electricity costs as compared to National Grid Basic Service.

It is important to note that <u>no action is required</u> by current participants. This change will be seen on the December 2025 bills. All accounts currently enrolled in the Program will remain with their current product offering and see the new rate and First Point Power printed under the "Supply Services" section of their monthly bill.

The North Adams Community Choice Power Supply Program has no fees or charges. However, anyone switching from a contract with a third-party supplier may be subject to penalties or early termination fees charged by that supplier. Ratepayers should verify terms before switching.

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the program against National Grid Basic Service. However, future savings cannot be guaranteed.
