WILLIAMSBURG SECURES AFFORDABLE LONG-TERM ENERGY WITH NEW SUPPLIER

WILLIAMSBURG, MA – The Town of Williamsburg has signed a thirty-six month contract with a new supplier, Direct Energy. Beginning with the November 2025 meter reads, the Williamsburg Community Choice Power Supply Program will have a new rate of \$0.14100 per kWh for a 100 percent green product derived from National Wind Renewable Energy Certificates (RECs).

For Williamsburg residents and businesses who are enrolled in the Town's Program, the current rate of \$0.14391 per kWh will expire with the November 2025 meter reads and the new rate of \$0.14100 per kWh will take effect. This represents a decrease of \$2 per month on the supply side of the bill given average usage of 600 kWh. Additionally, this new rate is 9 percent lower than National Grid's Residential Basic Service rate of \$0.15484 per kWh. Residents can expect to see an average savings of \$8 per month for the months of November 2025 through January 2026.

Williamsburg launched its electricity program in November 2017 in an effort to develop an energy program that would be stable, affordable and incorporate renewable energy. From inception through March 2025, the Program has saved residents and small businesses over \$766 thousand in electricity costs as compared to National Grid Basic Service.

It is important to note that <u>no action is required</u> by current participants. This change will be seen on the December 2025 bills. All accounts currently enrolled in the Program will see the new rate and Direct Energy printed under the "Supply Services" section of their monthly bill.

The Williamsburg Community Choice Power Supply Program has no fees or charges. However, anyone switching from a contract with a third-party supplier may be subject to penalties or early termination fees charged by that supplier. Ratepayers should verify terms before switching.

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the program against National Grid Basic Service. However, future savings cannot be guaranteed.
